Did you enter the US before your 16th birthday?

Proof of entry before your 16th birthday:

- Passport with admission stamp
- Form I-94/I-95/I-94W
- School records
- Any INS or DHS document stating your date of entry.
- Travel records
- Hospital or medical records





At the time of filing will you be over 15 years old and younger than 31 years old?

If you are under 15 years old, and you are currently in removal proceeding or have a final order of removal, you may be eligible. If you are over 31 years old you are not eligible.





Were you physically present in the US on June 15, 2012?

Proof of presence in U.S. on June 15, 2012

- Rent receipts or utility bills
- Employment records
- School records
- Military records
- Official records from a religious entity
- Money order receipts for money sent in or out of the country





Are you currently enrolled in school, have graduated from High School, or are currently enrolled in a GED program or have obtained your GED?

Proof of your student status

- School records
- U.S. high school diploma
- U.S. GED certificate





If you answered YES to the above questions, then you might be eligible for DACA.
